Found 3/4" iron pipe monument at the end of a 1415' radius curve on Ambassador Dr., 481.31 northeasterly of Maryvale Wy., as described in book 75 of maps, at page 19 filed in the office of the Recorder of Sacramento County, California. Set 3/4" Sacramento County brass tags in concrete for reference points. Refer to Sacramento County field notes A-259, page RP-08, 4/20/2007.

Replaced original monument on 7/2/2007 with 2" brass disc in monument well stamped "City of Rancho Cordova" in original position after original monument was destroyed as a result of construction.
