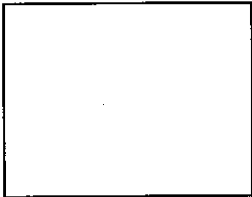

Found 3/4" iron pipe monuments on the centerline of Larry Way at the E.C. 21' west of Alta Lorraine Way, at the intersection of Alta Lorraine Way and at the B.C. & E.C. of the 165.92' radius curve, 21' west of Alta Lorraine Way, as shown on the "Plat of SCOTLAND UINT NO. 2" filed in the Office of the Recorder of the County of Sacramento in Book 66 of Maps, at Page 9. Set 3/4" Sacramento County brass tags in concrete for reference points. Refer to Sacramento County field notes A 266, page 70, 7/9/2007.

A Description of the Physical Condition of the Monument as Found and as Set or Reset:

Replaced found monuments on 3/24/2008 with 2 1/2" brass discs stamped "Sacramento Co. Municipal Services" in monument wells after found monuments were destroyed as a result of construction.

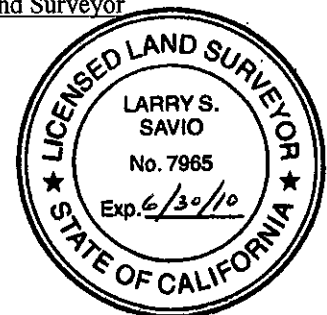
